

Minutes of the Circle Relaxation Committee Meeting to consider the case for compassionate appointment of dependents of deceased/missing departmental officials under compassionate grounds for the vacancy year 2018.

The Circle Relaxation Committee constituted by the competent authority in accordance with the Directorate's order vide no. 17-4/2017-SPB I/C dated 13.08.2020 with the following officers to consider the cases of dependents of employees of the department who died while in service/missing, for appointment on compassionate grounds in relaxation of normal Recruitment Rules and met on 01.10.2021.

2. Total 18 (Eighteen) cases completed in all respect received upto 31.12.2018 including the cases not recommended due to less merit point than the merit point of last recommended candidate in last CRC meeting held on 16.07.2019, have been taken into consideration by the CRC for the vacancy year 2018.
3. The Circle Relaxation Committee examined the list of candidates in Annexed documents, data regarding indigent conditions of the family, number of dependents, number of un-married daughters, number of minor children, left over service for discharge, value of movable/immovable property, family earning members of family per month, terminal benefits, immediate relief, physically/mentally challenged & chronic disease, grace points (widow) and total points gained as per norms prescribed by Postal Directorate, New Delhi vide letters no. 37-36/2004-SPB-I/C dated 20.01.2010, no. 37-4/2013-SPB-I/C dated 04.02.2013, 12.06.2013, no.37-4/2013-SPB-I/C(P) dated 11.03.2015, no. 37-4/2013-SPB-I/C dated 13.01.2016, no. 17-01/2019-SPG-II dated 09.01.2020, no. 17-4/2018-SPG-II dated 25.02.2020, no. 17-4/2008-SPG. II dated 28.09.2020, no. 17-05/2020-SPG-II dated 03.03.2021, and no. 17-4/2018-SPG II/PT-I dated 24.05.2021 & 25.05.2021.
4. As per order of the Postal Directorate, New Delhi letter no. 24-73/2012-SPB-I/C dated 13.04.2012, the recommended cases having more than 05 (five) years old needs to be submitted to Directorate for getting approval.
5. Out of total 18 (eighteen) cases, the Circle Relaxation Committee recommends 04 (four) cases as detailed in PART-A, whereas 14 (fourteen) cases not recommend as detailed in PART-B, due to lesser merit point than the merit point of last candidate acquired as 70 in PA/SA cadre, 54 in Postman cadre and 77 in MTS cadre as well as non submission of Matriculation certificate from recognized Board.
6. The cases Not Recommended by the Circle Relaxation Committee as detailed in PART-B will be placed before the next CRC for the vacancy year 2019 for consideration.
