In pursuance of the Postal Directorate letter no A-34012/01/2021-DE dated 09.08.2021 notification for conducting LDCE/Competitive Examination for promotion/recruitment to the cadre of PAs/SAs/PA(CO) from Postman/Mail Guard/MTS/GDS for the year 2021 (01.01.2021 to 31.12.2021) were issued vide letter no. R & E-20/LGO Exam/Postman-MTS to PA-SA/2021 dated 13.09.2021, R & E-20/LGO Exam/CO/2021 dated 13.09.2021 and R & E-20/LGO Exam/GDS to PA-SA/2021 dated 13.09.2021.

2. The followings are the qualifying criteria for each paper for LDCE/Competitive examination from Postman-MG/MTS (PO & RMS)/MTS(CO) and GDS to PA/SA cadre:-

3. The followings are the qualifying criteria for Paper-III (Data Entry Skill Test) DEST for LGO exam (Postman/MG/MTS to PA/SA) and for Competitive Exam from GDS to PA/SA as per Dte. Letter no. 17-08/2018-SPN-I dated 09.08.2021.

4.. 
(i) Annexure-I- List of successful departmental candidates selected from Postman/Mail Guard and MTS to PA/SA and their allotment to respective Division.

5. Every care has been taken while preparing the result, however if, any discrepancies come to notice, it may be reported to this office immediately before issuing the result to the successful candidates.




6. If the candidature of the candidate is provisional, the result should be announced after taking decision on the ground on which provisionally permitted and report should be submitted to this office before issuing appointment order.
7. If any disciplinary/vigilance/court case is pending against the candidate, the prescribed instructions of the department may be followed before effecting recruitment under intimation to this office. Divisional Heads/Unit Heads must ensure that officials are not undergoing any punishment or any disciplinary case is pending.
8. The candidate is to be appointed in the allotted division after completing all pre-appointment formalities. The certificate of community (SC/ST/OBC/EWS/PH) of candidates should be verified before issue of appointment order if candidate has been allowed on the basis of reservation. Verification of educational certificate as per eligibility of GDS should also be ensured before appointment.
9. The name of candidate against the Roll No. Concerned has been shown as furnished by the Divisional/Unit heads. If, however, any mistakes in the Name/Roll No./Community of the candidate is noticed, the same may be corrected under intimated to this office.
10. The selected candidate should assume the charge at new place of posting within 30 days after issue of this letter. In case he does not want to go on recruitment they will submit their refusal within 15 days from the issue of this letter. Concerned Divisional heads will issue his place of posting within a week from issue of this letter after observing all the formalities of appointment.
11. If any discrepancies/ irregularities/ omissions found in name, roll no., marks, community, etc. at any stage against the candidate, the result of the said candidate to be cancelled.
12. Necessary action may be taken for in-house/induction training as per instructions issued time to time in this regards.
