8. The selection of the candidate is subject to the provisions of relevant RRs and other conditions (pattern & syllabus) laid down in the rules. The Divisional Heads will issue appointment to the candidates selected in para 7 in the format prescribed. They, before issuing appointment to the candidates, will check the result with reference to their recommendations and other criteria and ensure that their selection is correct as per the recommendations and the conditions/criteria for qualifying the exam. **In case, any discrepancy/irregularity/omission is found, they will not issue the appointment order and will bring the discrepancy promptly to the notice of this office confidentially.** The concerned Divisional Heads will issue appointment order of the candidates selected after fulfilling the pre appointment formalities as prescribed by the Directorate from time to time.

9. If the candidature of any candidate is provisional, the result should be announced after taking decision on the ground on which provisionally permitted and report should be submitted to this office before issuing appointment order.
10. If any, disciplinary/vigilance case/Court Case/CBI case is pending against the candidate, the prescribed instructions of the department may be followed before effecting promotion under intimation to this office. Divisional Heads/Unit Heads must ensure that candidates are not undergoing any punishment or any disciplinary case is pending.
11. The name of the candidates has been arranged in order of merit in the examination. The candidates are to be appointed in the allotted division after completing all pre-appointment formalities. The candidature of SC/ST/OBC/EWS/PH candidates should be verified before issue of appointment order, if candidate has been allowed on the basis of reservation. Verification of educational certificate as per eligibility of GDS should also be ensured before appointment.
12. The names of the candidates against the Roll No. Concerned has been shown as furnished by the Divisional/Unit Heads. If, however any mistakes in the name/roll no./community of any candidate is noticed, the same may be corrected under intimation to this office.
13. The selected candidates should assume the charges at new place of posting within 30 days after issue of this letter. In case, they do not want to go on promotion they will submit their refusal within 15 days from the issue of this letter. Concerned Divisional Heads will issue their place of posting within a week from issue of this letter after observing all the formalities of appointment.
14. The Division wise marks list of 620 candidates who appeared in the examination is enclosed as Annexure-A for the information of the candidates.
