In pursuance of Circle Office, Ranchi notification no. R&E-16/Postman-MG/Exam/2019 dated 20.08.2019, examination for recruitment from GDS to the cadre of Postman/Mail Guard was held on 29.09.2019 for the vacancies of the year 2018 and 2019. Data Entry Skill Test (DEST) was conducted on 08.03.2020 on the basis of marks secured by the candidates in Paper-I and Paper-II (qualifying only) and result was declared on 19.03.2020.

16 candidates declared successful in the above said examination held on 29.09.2019 also declared successful in the Competitive examination for recruitment to the cadre of PA/SA from GDS held on 15.09.2019.

Out of 16 candidates, 14 candidates have joined as PA/SA and submitted their unwillingness for Postman/Mail Guard whereas two candidates joined in Postman cadre. Thus, total vacancy arisen (16-2)=14 due to declining of promotion as under: -

6. If the candidature of any candidate is provisional, the result should be announced after taking decision on the ground on which provisionally permitted and report should be submitted to this office before issuing appointment order.
7. If any disciplinary case is pending against the candidate, the prescribed instructions of the department may be followed before effecting recruitment under intimation to this office. Divisional Heads/Unit Heads must ensure that officials are not undergoing any punishment or any disciplinary case is pending.
8. The names of the candidates have been arranged in order of merit in the examination. The candidates are to be appointed in the allotted division after completing all pre-appointment formalities. The certificate of community (SC/ST/OBC/EWS/PH) of candidates should be verified before issue of appointment order if candidate has been allowed on the basis of reservation. Verification of educational certificate as per eligibility of GDS should also be ensured before appointment.
9. The names of candidates against the Roll No. Concerned has been shown as furnished by the Divisional/Unit heads. If, however, any mistakes in the Name/Roll No./Community of any candidates are noticed, the same may be corrected under intimated to this office.
10. The selected candidates should assume the charge at new place of posting within 30 days after issue of this letter. In case they do not want to go on recruitment they will submit their refusal within 15 days from the issue of this letter. Concerned Divisional heads will issue their place of posting within a week from issue of this letter after observing all the formalities of appointment.


